#### DISCLAIMER

The Edmonton Youth Orchestra Association and its directors, officers, employees, contractors, agents, volunteers, members and representatives (collectively referred to as "the EYO"), are not responsible for any injury, loss or damage of any kind whatsoever sustained by any person or their property while participating in events, activities, travel or promotions with the EYO and all related activities associated with the EYO, including injury, loss or damage which might be caused by the negligence of the EYO.

#### ASSUMPTION OF RISKS

In consideration of the EYO allowing me or my child to participate in training, practice, events, activities, travel, or promotions with the EYO and all related activities associated with the EYO, including participation in out-of-town workshops and/or concerts, I acknowledge that I am aware of the possible RISKS, DANGERS AND HAZARDS associated with participation with the EYO including the possible **risk of severe or fatal injury** to myself or others, property damage, or property loss. These risks include but are not limited to the following:

- The risks *associated* with travelling to and from out-of-town workshops and/or concerts on the transportation arranged by EYO, including stops along the way
- The possibility of personal injury incurred while getting on or off or moving about while on board the transportation (inside or outside of the mode of transportation) being used for travel to and from out-of-town workshops and/or concerts, being knocked down or being involved in a physical confrontation whether caused by myself or someone else
- The risks associated with traveling to and from the out-of-town workshops and/or concerts or other EYO events and activities by private transport
- Medical problems arising before, during or after the out-of-town workshops and/or concerts
- Failure to follow the **EYO Code of Conduct**
- Failure to follow the instructions and directions of members of the EYO, chaperones, or the persons in charge of the out-of-town workshops and/or concerts
- Actions of myself or my child or others during unsupervised and free time
- Misuse of electronic and social media devices, apps and online platforms
- Damage or theft of musical equipment

**I, for myself or my child, voluntarily accept and fully assume** all such risks, dangers and hazards and the possibility of personal injury, death, partial or permanent disability, property damage or loss resulting from my, or my child, **participating with the EYO** and attending events including out-of-town workshops and/or concerts.

**I, FOR MYSELF OR MY CHILD, VOLUNTARILY ACCEPT AND FULLY ASSUME** all responsibility to provide myself or my child with appropriate medical, health, travel, property or other insurance coverage I **ACKNOWLEDGE THAT I AM SOLELY RESPONSIBLE to obtain appropriate medical and/or health insurance for myself or my child. No medical or health insurance will be provided by the EYO. In the event of a medical or health problem, I acknowledge that the EYO accepts no responsibility whatsoever for any costs associated with a medical or health problem nor will the EYO pay for any medical or health expenses that may be incurred by the Participant.**

**I ACKNOWLEDGE THAT I AM SOLELY RESPONSIBLE** to obtain appropriate travel and/or property insurance. No travel or property insurance will be provided by the EYO. The EYO does not provide any coverage for the protection of musical instruments of members and participants. The travel and/or property insurance should, among other things, provide coverage against loss due to damage or theft of property, personal accident and personal liability. I acknowledge that the EYO accepts no responsibility whatsoever for any loss associated with these types of risks nor will the EYO pay for any expenses that may be incurred by the Participant relating to these matters.

## **RELEASE OF LIABILITY and AGREEMENT NOT TO SUE**

In consideration of the EYO allowing me or my child to participate with the EYO, I agree on behalf of myself and/or my child:

- 1. TO ASSUME and ACCEPT ALL RISKS** arising out of, associated with or related to my, or my child, **participating with the EYO** including but not limited to out-of-town workshops and/or concerts and all related activities, even though such risks may be caused by the negligence of the EYO.
- 2. TO WAIVE and RELEASE the EYO** from any and all liability for any loss, damage, injury or expense that I or my child may suffer, or that my next of kin may suffer as a result of my, or my child's, **participation with the EYO** including but not limited to out-of-town workshops and/or concerts due to any cause whatsoever, including negligence, breach of contract, or breach of any duty of care arising by virtue of the common law or any legislation.
- 3. TO INDEMNIFY and HOLD HARMLESS the EYO** from any and all liability for any damage to the personal property of, or personal injury to, any third party resulting from my, or my child's, **participation with the EYO** including but not limited to out-of-town workshops and/or concerts
- 4. TO INDEMNIFY and HOLD HARMLESS the EYO** from any claims whatsoever arising from any cancellations, injury, loss, accident or delay that may arise from the provision of any type of accommodation, facilities and equipment, or mode of transportation used in connection with my **participation with the EYO** and all related activities including but not limited to out-of-town workshops and/or concerts
- 5. TO INDEMNIFY and HOLD HARMLESS the EYO** from any and all claims, demands, actions and costs for any loss, injury, damage or expense whatsoever that might arise out of my, or my child's, **participating with the EYO** and all related activities including but not limited to out-of-town workshops and/or concerts even though such claims, demands, actions and costs may be caused by the negligence of the EYO.
- 6. TO ACCEPT and RECOGNIZE the AUTHORITY of CHAPERONES** who are expected to act in a reasonable manner in the role of parents and event organizers and who have authority to deal with infractions of the code of conduct or other matters which could jeopardize the safety of orchestra members or property.

## **CONSENT TO MEDICAL TREATMENT**

On behalf of myself and/or my child I hereby consent to and authorize such emergency or other medical treatment as may be deemed advisable in the event of accident, injury, or illness during my **participation with the EYO** and while attending events including out-of-town workshops and/or concerts. The EYO is not responsible for administering medication, managing medical conditions or allergies.

**AUDIOVISUAL RELEASE**

The EYO is granted the:

- 1. **Right to publish and use any photograph in which I or my works appear** for the purposes of EYO archival, marketing, publicity and public relations projects;
- 2. **Right to record and exhibit concerts, rehearsals, and studio sessions in which I participate** in audio, video, or any other media for EYO archival, marketing, publicity and public relations projects.

EYO CDs & DVDs produced for archival purposes will display **“For personal use only. Must not be duplicated or posted on the internet”**. This must be strictly observed.

### CODE OF CONDUCT 2023-2024

***PARTICIPANTS UNDER THE AGE OF 18 (MINOR PARTICIPANTS) MUST REVIEW THIS DOCUMENT WITH THEIR PARENT OR GUARDIAN AND HAVE THEIR PARENT OR GUARDIAN AGREE AND SIGN ON THEIR BEHALF***

Help us make your participation with the Edmonton Youth Orchestra an enjoyable and memorable experience for yourself, other orchestra members, as well as EYO staff and volunteers. Avoid problem situations! Take care of yourself and your belongings. Be positive, pleasant, co-operative and responsible. Always conduct yourself in a manner that will be a credit to yourself, to your parents, and to the EYO. **Please be aware that the EYO Code of Conduct will be strictly enforced.**

Each orchestra member is expected to:

- Be on time for all scheduled activities. Section leaders will check that all members are present at rehearsals.
- Be responsible for their personal items, concert dress, and particularly their own instrument and music.
- Obtain their own insurance for themselves and their property, including insurance on their musical instruments and equipment and personal devices.
- Bring their Alberta Health Care Card to any events outside of Edmonton and keep it with them at all times.
- Respect fellow members, EYO staff and volunteers in all EYO settings (in-person and/or online rehearsals, concerts, workshops, etc). Threatening, harassing, defamatory, libelous or deceptive language and/or behaviour will not be tolerated. (See EYO Member Protection & Member Behaviour Policies).
- Follow the EYO's Social Media policy. Online social media activities and postings on internet websites and application software, online communities and sharing platforms must uphold the EYO's reputation in all respects. The Social Media policy applies to EYO Orchestra members, staff, contractors and volunteers posting EYO-related material on any type of social media, or on other electronic application software or online platforms, at any time. Parents and guardians are requested to respect this policy as well:
  - The use of EYO logos and content without prior consent from the EYO general manager, music director or Board is prohibited.

- Orchestra members, staff, contractors and volunteers are prohibited from posting images of EYO members, staff, contractors or volunteers without their permission.
- Posting of audio / visual recordings of EYO rehearsals or performances are only permitted with the advance approval of the Music Director.
- Social media comments about EYO, other members or other orchestras' rehearsals or performances must be positive in nature.
  - Any contributions on EYO Social Media that could be viewed as malicious, obscene, threatening or intimidating, that disparages staff, students, families, volunteers or the EYO organization, or that might constitute harassment or bullying will be removed.
- Positive social media promotion of EYO concerts is encouraged, and sharing of promotional materials such as concert posters does not require permission.

**In addition, EYO has a zero tolerance policy regarding illegal drugs, alcohol and marijuana. Anyone found to be in possession of or under the influence of illegal drugs, alcohol or marijuana will face disciplinary action. Alcohol, marijuana or illegal drug consumption during EYO events and activities is strictly prohibited. This includes those traveling on their own to EYO events and activities. In addition, alcohol and marijuana will be confiscated by the chaperones. Anyone who is found to be in possession of or under the influence of alcohol or marijuana and anyone who provides alcohol or marijuana to anyone under the age of 18 years will also face disciplinary action. Be aware that Law Enforcement will be involved for any illegal drugs.**

**Protocol for out-of-town Workshops and Concerts:**

- A list of orchestra members will be assigned to each volunteer adult chaperone, who will help members with any problems or concerns. Because of the age range of orchestra members and to ensure a smooth running, safe and successful out-of-town events, all orchestra members must physically Sign-in/Sign-out with their designated chaperone if they want to engage in any optional or unscheduled activity (**texting in not acceptable**). Members are advised not to be on their own but to always be with at least one other EYO member, or a chaperone.
- In the interest of maintaining privacy and respect for one another, orchestra members are only allowed to be in the room of members of the opposite sex prior to curfew and only while the room door is open.
- For all orchestra members under 18 years of age: (a) your chaperone will check that you are in your room at curfew, and (b) you must be accompanied by a chaperone when away from accommodations or rehearsal/concert grounds.
- A **curfew of 11.00 p.m.** will be strictly enforced for all orchestra members under 18 years of age.

- All orchestra members aged 18 years and over who desire to leave the accommodations or rehearsal/concert grounds must **physically Sign-in/Sign-out** with their designated chaperone and must be back in their rooms **by 12:00 midnight. Be aware that if your chaperone cannot account for you, EYO may take drastic search measures, which could involve the RCMP.**The Hotel asks that respect and consideration be given to their other guests. Please be quiet and refrain from wandering from floor to floor. For your own protection, please lock the door to your room every time you leave, even for a moment. No smoking is permitted in dorms/residence wings/rooms.

**Any orchestra member who acts contrary to the EYO Code of Conduct will face disciplinary action which could include dismissal from the Edmonton Youth Orchestra for some or all of the balance of the year, loss of eligibility for EYO scholarships, or other consequences. Disciplinary action will be determined by the EYO Board of Directors in consultation with the Music Director and Manager.**
